## **OFFICE MEMORANDUM**

- 1. Instructions relating to the temporary withdrawal of the Meghalaya Delegation of Financial Powers Rules, 2006 issued by this Department starting with Order No. FEA 93/2004/163 dated 18.07.2019 and the subsequent orders stand withdrawn.
- 2. However, from the 3rd quarter of the C.F.Y 2022-23, the following instructions should be adopted and strictly adhered to:
  - i) All ongoing schemes relating to only the following object-heads will have to obtain Finance Department's approval:
    - 21-Materials & Supplies, stores & equipment
    - 26-Advertising and Publicity
    - 27-Minor Works, Maintenance
    - 28-Professional Services
    - 31-Grant-in-aid
    - 33-Subsidies
    - 34-Scholarship/Stipend
    - 50-Compensation other charges, payments out of discretionary grants for high dignitaries, discounts customs duty.
    - 51-Motor Vehicles
    - 52-Machinery & equipment, tools & plants
    - 53-Major Works, Land and Buildings
    - 54-Investments
    - 55-Loan, Advances
  - ii) All items of expenditure that have received LOA/LOC during the CFY 2022-2023, irrespective of object heads, are deemed to be exempted from Point 2(i) above.
  - iii) With regards to the re-appropriation of savings, the powers of the departments to re-appropriate as per the DFP Rules are temporarily withdrawn. Re-appropriation of savings may be done only with the prior concurrence of the Finance Department.
