OFFICE MEMORANDUM**

Dated Shillong, the 28th April, 2020

FEA/56/2020/31– The current unprecedented situation due to COVID-19 and the consequent lockdown is likely to slow down the National and State economies. It is therefore necessary to put in place expenditure control and cash management systems so that resources are available for effective management of COVID-19 situation.

Accordingly, the following measures with regard to salaries for the period April, 2020 (to be paid in May, 2020) and May, 2020 (to be paid in June, 2020) shall be made:

1. There shall be deferment of 50% in the gross salary, in respect of Hon'ble Chief Minister, Hon'ble Deputy Chief Minister and Hon'ble Ministers.
2. There shall be deferment of 50% in the gross salary, in respect of All India Services Officers, viz. IAS, IPS, IFS and Central Services officers on deputation to the State Government.
3. There shall be deferment of 35% in the gross salary of Group A and B officers and 25% in respect of Group C staff of all departments except the officers and staff of the Departments of Health and Family Welfare and the Group C employees of Home (Police) and Home (Civil Defence and Home Guards).
4. The proportion of the deferment in salaries for Group A, B and C employees indicated above will also be applicable to all the institutions being provided Grant-in-aid (Salary) by the State Government except for Group C employees of the Municipal Boards.
5. No deferment shall be made in salaries payable to all Group D employees.
6. No deferment will be made in the payment of Pensions.
